CHAIRMAN'S STATEMENT

RESULTS

The consolidated turnover of the Company and its subsidiaries for the year ended 31 March 2012 amounted to HK\$36,325,000 (2011: HK\$44,638,000) of which HK\$21,586,000 (2011: HK\$24,973,000) was attributable to the business of comics publication of the Group, HK\$4,899,000 (2011: HK\$6,832,000) was attributable to the crude oil exploration services of the Group, HK\$26,000 (2011: HK\$146,000) was attributable to the smart card business, HK\$5,141,000 (2011: HK\$4,167,000) was attributable to retailing and wholesales business, HK\$2,308,000 (2011: HK\$2,215,000) was attributable to other business and HK\$2,365,000 (2011: HK\$6,305,000) was attributable to the discontinued operations of investment properties. Loss for the year attributable to equity holders, taking into account taxation, was HK\$49,107,000 (profit for 2011: HK\$9,006,000). The loss per share was HK4.7 cents (earning per share for 2011: HK1.1 cent).

FINAL DIVIDEND

The Board of Directors has resolved not to declare any final dividend for the year ended 31 March 2012 (2011: Nil).

BUSINESS REVIEW

The aftershock of the global economic turmoil has affected many of our businesses. In order to ensure our Group was operating efficiently and effectively, we have set up preventive measures as much as we could, and have made provisions on investments that had lost value. At the same time, we have also refocused on our key areas of licensing and animation business, as well as extended our arms to online social music gaming platform. Although this development has resulted in additional cost, we have been able to offset this with the exciting arrival of a beta version in the second half of 2012, and a final version shortly after. Overall, it may appear that developmental costs and fair value changes in investments have been weighed in heavily on this year's earnings, nevertheless we have been able to maintain steady revenue on most recurring projects. We are excited that our Group has successfully persevered the storms; we are finally beginning to see the fruits of our hard work, and are convinced that full harvest is on its way.

With respect to the technology-business, our Group has secured suitable cooperative partners to enhance and further commercialize our existing technologies. In the comics business, our Group has fortified its licensing business with additional resources and business partners, actively pursued opportunities in animation and movie production, while continued to reach out to other media forms. One of the highly embraced ideals of Culturecom has always been about propelling Chinese culture to the mainstream; and in light of this, our Group is at the final stages of developing an Asian-flavored animation/comic creation interface that uses our very own Generating Engine technology. Our huge animation/comic image database, along with this Generating Engine, will allow the mass public to participate in the production process; lowering cost on one hand, while being able to appeal to a new generation of artists.

Aside from technology and comics, we have taken a prudent approach in the Group's petroleum extraction business. Against the backdrop of credit tightening and economic uncertainties in China, our Group has devoted much of its effort on fine-tuning the existing oil exploration facilities, and has left much of the new extraction work to be completed in the upcoming years. Some financial fluctuations during the process were unavoidable as a result, but our Group remains confident that once the oil extraction ventures in Shengli Oilfield and Chaoshui Basin pick up in the near future, our yields will dash off to highly promising results.

PROSPECTS

Looking ahead, our Group is excited about its future projects, and optimistic of its upcoming journey. We will continue to foster our relationships with the existing cooperative partners and business associates. Internet, an effective communication tool that bridges the gap between people residing in different parts of world, has been developing rapidly over the past few years, evident in the popularity of Facebook, Twitter and Youtube. Our Group currently believes strongly in the enormous potential of online social music gaming platform. Leveraging on the Group's IP database, animation generating engine and extensive business network in the Southeast Asia region, our Group will soon release—Ucan—an online social platform for gamers, animators, shoppers, developers, and music lovers to share their creative ideas to anyone they wish, even to those around the world. Furthermore, our Group will continue to make further inroads to our core business of animation and comics market in Asia, such as setting up educational programs and training grounds for artists and like-minded animators in China. Last but not the least, we are immensely grateful to our shareholders' continuing trust in us; we promise to, as we always have, look out for their best interests, and strive for the soundest investment strategies.

I would like to express my sincere thanks to the Board of Directors, our management and staff for their continued dedication in the past year, and to all our customers, suppliers, business partners and shareholders for their enthusiastic support of the Group.

MANAGEMENT DISCUSSION AND ANALYSIS

FINANCIAL RESULTS

For the year ended 31 March 2012, the Group's overall revenue from external customers decreased by 11.4% to HK\$33,960,000 of which approximately HK\$21,586,000, HK\$4,899,000, HK\$26,000, HK\$5,141,000 and HK\$2,308,000 (2011: HK\$24,973,000, HK\$6,832,000, HK\$146,000, HK\$4,167,000 and HK\$2,215,000) were attributable to our continuing business of publishing, crude oil exploration services, electronic card service, retailing and wholesales and others respectively.

The revenue from discontinued operations of investment properties decreased by 62.4% to HK\$2,365,000 and the disposal of the whole block of Culturecom Centre was completed on 23 September 2011, resulting in a total net gain of approximately HK\$54,096,000 (2011: HK\$78,406,000).

The Group's consolidated net loss attributable to the owners of the Company for the year was HK\$49,107,000 (2011: profit HK\$9,006,000), and the loss per share for the year was HK4.7 cents (2011: earnings per share HK1.1 cents). This decline in performance was largely due to fair value loss of financial assets at fair value through profit and loss of HK\$41,330,000, impairment of available-for-sale financial assets of HK\$5,000,000. Overall, by focusing on core comics operations and expanding into the online social music gaming platform, the Group has gradually progressed from its less-than-desirable position to a much more stable and hopeful present state. Therefore, the Group is optimistic of its future, as the steps taken so far have demonstrated that what is to come can only be better.

Also, as of 31 March 2012, the Group's net asset value was HK\$758,936,000 and net asset value per weighted average number of 1,035,758,000 shares of the Company was approximately HK\$0.73 (2011: HK\$0.96).

WARRANTS

On 7 March 2011, the Company entered into a placing agreement with an independent placing agent in relation to the private placing of 137,850,000 warrants (the "2013 Warrants") conferring rights to subscribe up to HK\$38,598,000 in aggregate for shares of the Company at an initial subscription price of HK\$0.28 per share, to not less than 300 placees who are independent third parties during the two years period from 3 May 2011 to 2 May 2013, both days inclusive. The placing of the 2013 Warrants was completed on 29 April 2011.

The net proceeds of the placing of approximately HK\$26,552,000 were used as general working capital of the Company.

During the year, registered holders of 5,710,000 units of the 2013 Warrants exercised their rights to subscribe for 5,710,000 shares in the Company at HK\$0.28 per share.

SUBSTANTIAL DISPOSAL

On 27 January 2011, the Group entered into a provisional agreement for sale and purchase with an independent third party on the disposal of the whole block of property located at 47 Hung To Road, Kwun Tong, Hong Kong (the "Disposal") at a consideration of HK\$286,000,000 (the "Consideration"). The Disposal was completed on 23 September 2011 and the Consideration was fully received by the Group. After the completion of the Disposal, the Group recorded a gain of approximately HK\$55,477,000 and the net proceeds will be used for future investments which may be in the principal line of business of the Group.

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2012, the Group had bank and deposits with financial institutions balances in aggregate of approximately HK\$434,531,000 and financial assets at fair value through profit and loss of approximately HK\$50,911,000. The Group has no significant exposure to foreign exchange rate fluctuation.

As of 31 March 2012, the Group had a net current assets of approximately HK\$557,621,000 (2011: HK\$554,309,000) and a current ratio of 17.63 (2011: 16.02). The Group's total liabilities as of 31 March 2012 amounted to approximately HK\$62,963,000 and represented approximately 8.3% (2011: 8.8%) to shareholders' equity.

Upon consideration of the above, the Directors have no doubt that the Group will have sufficient liquidity to finance its daily operations, as reflected by its healthy financial status with a wealth of cash flow and other resources. As always, the Group will continue to follow prudent and disciplined cash management practices on any excess liquidity.

EMPLOYMENT AND REMUNERATION POLICIES

As of 31 March 2012, the Group had a total of 116 (2011: 120) employees. Total staff costs incurred during the year amounted to approximately HK\$19,669,000 (2011: HK\$22,163,000). Remuneration packages are maintained at competitive levels and reviewed by the management on a periodical basis. Discretionary bonuses and incentive share options are awarded to certain directors and employees according to the assessment of individual merit and performance.

The Company acts as an investment holding company. The activities of its principal associates and subsidiaries are set out in notes 18 and 41 to the consolidated financial statements respectively.

MAJOR CUSTOMERS AND SUPPLIERS

The aggregate turnover during the year attributable to the Group's five largest customers accounted for 65.69% of the Group's turnover, of which 26.62% was attributable to the largest customer.

The aggregate purchases during the year attributable to the Group's five largest suppliers accounted for 69.95% of the Group's total purchases, of which 47.56% was attributable to the largest supplier.

At no time during the year did a director, an associate of a director or a shareholder of the Company (which to the knowledge of the directors own more than 5% of the Company's share capital) have an interest in any of the Group's five largest customers or suppliers.

The directors of the Company, including executive, non-executive and independent non-executive directors ("INEDs") are subject to retirement by rotation and re-election at the annual general meeting of the Company. In accordance with Clauses 101, 110(A) and 190(v) of the Company's Bye-Laws, Messrs. Chen Man Lung, Chu Bong Foo, Tang Kwing Chuen Kenneth and Lai Qiang will retire and, being eligible, offer themselves for re-election at the forthcoming annual general meeting.

None of the Directors proposed for re-election at the forthcoming annual general meeting has a service contract which is not determinable by the Group within one year without payment of compensation (other than statutory compensation).

The Company has received the annual confirmation of independence from each of the INEDs as required under Rule 3.13 of Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The Company considered all INEDs to be independent.

Chairman and Non-Executive Director

Mr. Chu Bong Foo, aged 74, is currently the Chairman of the Group. Mr. Chu joined the Group in May 1999 and was appointed as Chairman and Non-Executive Director on 21 January 2011. He is responsible for the design and development of the Group's Chinese information infrastructure. Mr. Chu is the inventor of the Cangjie method, the most widely available Chinese input method and has engaged himself in the development of Chinese character generating technology for over 20 years. He is renowned for "the father of the modern Chinese computing".

Executive Directors

Ms. Chow Lai Wah Livia, aged 51, is the Vice Chairman of the Group. Ms. Chow joined the Group in April 2008; she was appointed as Executive Director on 17 May 2011 and was re-designated as Vice Chairman of the Group on 26 March 2012. She is also a member of our Corporate Governance Committee and the Nomination Committee. Ms. Chow is currently the Director of L&W Holding Limited which is one of the substantial shareholders of Culturecom Holdings Limited. Ms. Chow is presently responsible for the corporate management of the Group. Prior to joining the Company, Ms. Chow was the President of East Universal Investments Inc., based in the United States for over 9 years. She has more than 20 years of extensive experience in executive development and corporate management.

Mr. Kwan Kin Chung, aged 43, joined the Group in 1998 and has been one of the Executive Directors since March 2008. Mr. Kwan is also the Managing Director of the Group and serves as the Director for several subsidiaries of the Group. He held the position of Vice President for the Group from 1998 to 2002 and was appointed as the acting Chief Executive Officer of the Company in April 2007. During the period serving as Vice President, Mr. Kwan was also the Vice Publisher of Tin Tin Daily News where he gained valuable experience in the media industry. Mr. Kwan holds the position of Managing Director of China Bio Cassava Holdings Limited whose shares are listed on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited. Mr. Kwan has extensive experience in business restructuring and corporate investment. He holds a Bachelor degree of Arts in Economics from Sun Yat-Sen University (Zhongshan University) PRC.

Mr. Chung Billy, aged 37, joined the Group in June 2007 and has been one of the Executive Directors since November 2007. Mr. Chung is also the Chief Operating Officer of the Group and serves as the Director for several subsidiaries of the Group. He is responsible for the Group's overall operation and business development, as well as human resources and accounting related managerial activities. Mr. Chung holds a Bachelor degree of Arts in Accounting from the University of Waterloo, Canada and a Master degree of Business Administration from the University of Toronto, Canada. As a member of the Canadian Institute of Chartered Accountants, he has over 10 years of extensive experience in the fields of accounting, consulting and investment banking. He is also a fellow member of the Hong Kong Institute of Certified Public Accountants. Prior to joining the Group, Mr. Chung acted as senior Project Director at Opes Asia Development Limited, whose shares are listed on the Main Board of the Stock Exchange of Hong Kong Limited.

Mr. Tang U Fai, aged 38, joined the Group as the Chief Technology Officer in May 2001 and has been one of the Executive Directors since March 2008. He is also a General Manager of Etown Online (Macau) Limited, a fully owned subsidiary of the Group. Mr. Tang has extensive experience in IT science and management. Mr. Tang holds a Bachelor degree of Science in Computer Science and Economics from the University of Victoria, Canada and a Master degree of Science in Software Engineering from the University of Macau.

Mr. Tang Kwing Chuen Kenneth, aged 34, joined the Group in October 2003 and has been one of the Executive Directors since December 2008. He is also a member of the Corporate Governance Committee of the Group. He was appointed as the Company Secretary of ViaGOLD Capital Limited in January 2007, a company whose shares are listed on Australian Stock Exchange. ViaGOLD Capital Limited is a controlled corporation of Harvest Smart Overseas Limited, which is one of the substantial shareholders of Culturecom Holdings Limited. Mr. Tang holds a Master degree of Commerce in Finance and a Bachelor degree of Science majoring in Information Systems from the University of New South Wales, Australia. He has extensive years of experience in the banking and finance industries.

Mr. Chen Man Lung, aged 46, was appointed as Executive Director of the Company in October 2009. Mr. Chen was an executive director of China Bio Cassava Holdings Limited till 18 June 2012 whose shares are listed on the GEM of the Stock Exchange. He was appointed as an independent non-executive director of Opes Asia Development Limited and Mobile Telecom Network Holdings Limited, both companies whose shares are listed on the Hong Kong Stock Exchange, and the chief financial officer of ViaGold Capital Limited, a company whose shares are listed on the Australian Stock Exchange. On public services, he currently serves as the Chairman of Academic Advisory Board of the Humanities program under Faculty of Arts of Hong Kong Baptist University, the director of the Hong Kong Baptist University Alumni Association Limited and founding member of the International Federation of Creative and Technology. He served as Academic Advisor of Visual Arts of Hong Kong Baptist University, the director of the Hong Kong Comics & Animation Federation Limited (HKCAF) and committee member of the Inbound Travel Agent Association Limited (HKITA). He was granted the Bachelor degree of Arts in Sociology and the Master degree of Arts in Chinese Studies from the Hong Kong Baptist University and the Hong Kong University of Science and Technology respectively. Mr. Chen has over 18 years of extensive experience in investment industry.

He is also a member of the Remuneration Committee of the Group and serves as the Director of several subsidiaries of the Group. Prior to joining the Group, Mr. Wan was the General Manager of China Merchants Transportation Group in the finance and accounting division. He is currently one of the Executive Directors of China Bio Cassava Holdings Limited, whose shares are listed on Growth Enterprise Market of the Stock Exchange of Hong Kong. Mr. Wan holds a Bachelor degree of Arts in Economics from Shanghai Maritime University, PRC.

Independent Non-Executive Directors

Mr. Tsang Wai Wa, aged 51, was appointed as an Independent Non-Executive Director of the Company in November 2009 and is also an independent non-executive director of China Bio Cassava Holdings Limited. Mr. Tsang served as an independent non-executive director of Opes Asia Development Limited from 7 April 2009 to 20 December 2011, all of their shares are listed on the Stock Exchange. Mr. Tsang is a Company Secretary of one of the listed companies in Hong Kong. Mr. Tsang holds the Bachelor degree in Finance and Accounting and a Master degree in Business Administration. He is a fellow member of the Chartered Association of Certified Accountants and an associate member of the Hong Kong Institute of Certified Public Accountants. He has extensive experience in auditing, accounting, company secretary and corporate finance.

Mr. Joseph Lee Chennault, aged 68, joined the Group in September 2004. Mr. Chennault is a member of the Audit Committee of the Group. He holds a Bachelor degree of Arts in Economics from University of San Francisco and a Master degree of Business Administration from Golden Gate University, both in the United States. He is a member of the California Society of Certified Public Accountants and has over 30 years of experience in accounting and auditing in listed companies.

He holds a Bachelor degree in International Finance (Professional Economics) under the International Trading Finance Department, from Sun Yat-Sen University (Zhongshan University), PRC. Mr. Lai is currently the Officer of Financial Settlement Centre for Shenzhen Huaqiang Holdings Limited. It is a large investment holding company with high technology industries as its core business. It has continuously been chosen as the Most Advanced Enterprise in Quality and Efficiency in China and the Top Foreign Exchange-Earning Enterprise in China for many years. Mr. Lai has over 10 years of practical experience in group enterprise fund management and financial management.

Mr. Tam Kam Biu William, aged 56, joined the group in 2 March 2012. Mr. Tam is currently one of the Executive Directors of China Bio Cassava Holdings Limited whose shares are listed on the Growth Enterprise Market Board of the Stock Exchange of Hong Kong Limited. Mr. Tam obtained a Master degree in Business Administration from York University, Canada and became an associate member of the Hong Kong Institute of Certified Public Accountants in 1987 and an associate of the Association of Chartered Certified Accountants in 1988.

Mr. Yu Huaguo, aged 45, joined the Group in May 2008. Mr. Yu is presently the Chief Executive Officer of the Group. Prior to joining the Group, he was the Executive Director of Jiuzhou Development Company Limited, whose shares are listed on the Stock Exchange of Hong Kong. Mr. Yu had also served at Zhuhai Jiuzhou Port Group Corporation (a substantial shareholder of JDCL) as Deputy General Manager. Mr. Yu holds a Master degree of Business Administration from the Hong Kong Polytechnic University. He has over 20 years of experience in finance, capital securities and enterprise management.

During the year, the Company had carried on a connected and continuing connected transaction, the details of which are disclosed below in compliance with the requirements of Chapter 14A of the Listing Rules.

(a) Extension of Repayment

On 16 July 2007, the Sale and Purchase Agreement (the "S&P Agreement") was entered into between Success Dynasty Limited ("SDL"), a wholly owned subsidiary of the Company, and Wealthy Concept Holdings Limited ("WCHL"), pursuant to which SDL agreed to acquire the 100% interest in Raise Beauty Investments Limited ("RBIL") from WCHL.

Under the S&P Agreement, WCHL has guaranteed to SDL that the audited net profit of RBIL and its subsidiaries for the year ended 31 December 2008 (the "Audited Net Profit") shall in aggregate be not less than RMB19,000,000 (equivalent to approximately HK\$21,554,169) (the "Profit Guarantee"). Eventually, the Profit Guarantee has not been achieved. WCHL, under the S&P Agreement, shall pay SDL in cash an amount of HK\$20,924,800 (equivalent to approximately RMB18,445,211) which equal to the difference between the Audited Net Profit and the Profit Guarantee on a dollar to dollar basis.

WCHL has repaid HK\$18,270,000 (equivalent to approximately RMB16,105,005) to SDL and the remaining balance of HK\$2,654,800 (equivalent to approximately RMB2,340,206) shall be payable in cash on or before 31 July 2012.

Mr. Tai Pang ("Mr. Tai") and Mr. Liao Chang Yuan ("Mr. Liao") holds 30% and 40% of the shareholding in WCHL respectively and Mr. Tai and Mr. Liao are directors of subsidiaries of the Company. Accordingly, under Chapter 14A of the Listing Rules, WCHL is an associate of Mr. Tai and Mr. Liao and both of Mr. Tai and Mr. Liao being connected persons of the Company. The entering into of the Supplemental Agreement between SDL and WCHL was constituted a connected transaction of the Company.

The directors (including the independent non-executive directors) of the Company, considered that the terms of the Supplemental Agreement were fair and reasonable and in the best interests of the Company and the shareholders of the Company as a whole and the Supplemental Agreement was entered into on normal commercial terms.

On 29 June 2010, the Group entered into a licensing agreement ("Licensing Agreement") with Mutual Work Media Investment Fund Limited ("Mutual Work"), of which Mr. Chen Man Lung, an executive Director of the Company, is holding 100% of the interests of Mutual Work. Pursuant to the Licensing Agreement, the Group granted to Mutual Work certain rights to exploit a section of the properties selected by Mutual Work, including any copyright work, characters, appearance of character, story title of the story, theme, dialogues or action embodied therein, for the production of movies.

The Licensing Agreement lasts for 3 years commenced from 29 June 2010. Detail of the transaction was set out in the announcement of the Company dated 29 June 2010. The annual cap for the Licensing Agreement is based on the royalty payment and the share of bonus on the global box office result. No royalty income received during the year. The annual cap for this transaction for the years ended 31 March 2012 and 2013 are HK\$5,010,000.

SUFFICIENCY OF PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the Directors, as at the date of this report, the Company has maintained sufficient public float as required under the Listing Rules.

AUDITOR

During the year, BDO Limited ("BDO") resigned as auditors of the Company with effect from 22 March 2012, and FTW & Partners CPA Limited ("FTW") was appointed as auditors of the Group with effect from 30 March 2012 to fill the casual vacancy occasioned by the resignation of BDO. The reason for this change of auditors is that taking into account the availability of internal resources in the next few months and the level of fees, BDO decided to resign as auditors of the Company.

The financial statements of the Company for the year ended 31 March 2012 were audited by FTW, who will retire and a resolution to re-appoint FTW as auditors of the Company will be proposed at the forthcoming annual general meeting.

INTRODUCTION

As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the Code.

Code Provision E.1.2

Under the code provision E.1.2, the Chairman of the board should attend the annual general meeting. The Chairman of the board, Mr. Chu Bong Foo, was unable to attend the annual general meeting of the Company held on 8 August 2011 as he was on business trip for other important business engagement. However, an Executive Director, present at the annual general meeting who then took the chair of that meeting in accordance with the Bye-Laws of the Company.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code as set out in Appendix 10 to the Listing Rules as its own code for dealing in securities of the Company by the Directors. NOMINATION COMMITTEE

According to the Bye-Laws of the Company, the Company established a Nomination Committee on 26 March 2012 with written terms of reference, to formulate nomination policy for the Board's consideration and implement the Board's approved nomination policy. The Board of Directors has the power from time to time to appoint any person as a director either to fill a casual vacancy or as an addition to the Board of Directors. The nomination shall be taken in consideration of the nominee's qualification, ability and potential contribution to the Company.

According to the written terms of reference, the Nomination Committee shall consists of three Directors, a majority of whom shall be independent non-executive Directors appointed by the Board of Directors from time to time. Currently, the Nomination Committee comprises Ms. Chow Lai Wah Livia, and two independent non-executive Directors, namely Mr. Tsang Wai Wa and Mr. Lai Qiang.

According to the Bye-Laws of the Company, the Company established a Corporate Governance Committee (the "CGC") on 26 April 2010 with written terms of reference. The CGC obligates to advise upon any transaction of the Company which the Board is proposed to enter or transact for and on behalf of the Company, and give a collective opinion to the Board as to the propriety, feasibility and prudence of entering into such transactions.

According to the written terms of reference, the CGC comprised of 4 members. Currently, the CGC was chaired by Mr. Chen Yen Lung ("Mr. Chen"). Mr. Chen participates in international financial investment over 20 years and has a strong and long-term business relationships with a number of international financial institutions.

1. GENERAL INFORMATION

Culturecom Holdings Limited (“the Company”) is a limited liability company incorporated in Bermuda. Its registered office address is Canon’s Court, 22 Victoria Street, Hamilton HM12, Bermuda and its principal place of business is Room 3201, 32th Floor, Singa Commercial Centre, 148 Connaught Road West, Hong Kong. The Company’s shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The principal activities of the Company and its subsidiaries (together the “Group”) comprise publishing, property investment which classified as discontinued operations in prior year, investment holding, exploration of crude oil services, Chinese information infrastructure and online social music gaming platform, electronic card service, retailing and wholesales and catering business. The Group’s principal places of the business are in Hong Kong and the People’s Republic of China (the “PRC”) and Macau.

On 27 January 2011, the Group entered into a provisional agreement for sales and purchase (“Provisional Agreement”) with an independent third party in relation to the disposal of all its investment properties, the whole block of Culturecom Centre, located at 47 Hung To Road, Kwun Tong, Kowloon (the “Disposal Property”) for a consideration of HK\$286,000,000 (the “Disposal”). The Disposal was approved at the special general meeting held on 23 March 2011 and the transaction was completed on 23 September 2011.

The financial statements are presented in Hong Kong Dollars (“HK\$”), which is also the functional currency of the Company and all values are rounded to the nearest thousand (“HK\$’000”) unless otherwise indicated.

The financial statements for the year ended 31 March 2012 were approved for issue by the board of directors on 25 June 2012.

2.1 Basis of preparation

The financial statements on pages 37 to 146 have been prepared in accordance with the Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standard ("HKASs") and Interpretations ("Int") issued by Hong Kong Institute of Certified Public Accountants ("HKICPA"). The financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the Rules governing the Listing of Securities on the Stock Exchange ("Listing Rules").

The significant accounting policies that have been used in the preparation of these financial statements are summarised below. These policies have been consistently applied to all the years presented, unless otherwise stated. The adoption of new or revised HKFRSs and the impacts on the Group's financial statements, if any, are disclosed in note 3.

The financial statements have been prepared under historical cost convention except for financial assets at fair value through profit or loss, investment properties including in assets classified as held for sale and available-for-sale financial assets which are stated at fair values. The measurement bases are fully described in the accounting policies below.

It should be noted that accounting estimates and assumptions are used in preparation of the financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements are disclosed in note 4.

2.2 Business combination and basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries made up to 31 March each year.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases.

Intra-group transactions, balances and unrealised gains and losses on transactions between group companies are eliminated in preparing the consolidated financial statements. Where unrealised losses on intra-group asset sales are reversed on consolidation, the underlying asset is also tested for impairment from the Group's perspective. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

2.3 Subsidiaries

Subsidiaries are entities (including special purpose entities) over which the Group has the power to control the financial and operating policies so as to obtain benefits from their activities. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Group controls another entity.

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. The results of the subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

2.4 Associates

Associates are those entities over which the Group is able to exert significant influence, generally accompanying a shareholding of between 20% and 50% of voting rights but which are neither subsidiaries nor investment in a joint venture.

In the consolidated financial statements, investment in associates is initially recognised at cost and subsequently accounted for using the equity method. Any excess of the cost of acquisition over the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities of the associate recognised at the date of acquisition is recognised as goodwill. The cost of acquisition is measured at the aggregate of the fair values, at the date of exchange, of assets given, liabilities incurred or assumed and equity instruments issued by the Group, plus any costs directly attributable to the investment. Any excess of the Group's share of the net fair value of the identifiable assets, liabilities and contingent liabilities over the cost of acquisition, after reassessment, is recognised immediately in profit or loss in the determination of the Group's share of the associate's profit or loss in which the investment is acquired.

Under the equity method, the Group's interest in the associate is carried at cost and adjusted for the post-acquisition changes in the Group's share of the associate's net assets less any identified impairment loss, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). The consolidated statement of comprehensive income includes the Group's share of the post-acquisition, post-tax results of the associate for the year, including any impairment loss on goodwill relating to the investment in associate recognised for the year.

Unrealised gains on transactions between the Group and its associates are eliminated to the extent of the Group's interest in the associates. Where unrealised losses on assets sales between the Group and its associates are reversed on equity accounting, the underlying asset is also tested for impairment from the Group's perspective. Where the associate uses accounting policies other than those of the Group for like transactions and events in similar circumstances, adjustments are made, where necessary, to conform the associate's accounting policies to those of the Group when the associate's financial statements are used by the Group in applying the equity method.

When the Group's share of losses in an associate equals or exceeds its interest in the associate, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associate. For this purpose, the Group's interest in the associate is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate.

After the application of equity method, the Group determines whether it is necessary to recognise an additional impairment loss on the Group's investment in its associates. At each reporting date, the Group determines whether there is any objective evidence that the investment in associate is impaired. If such indications are identified, the Group calculates the amount of impairment as being the difference between the recoverable amount (see note 2.19) of the associate and its carrying amount.

2.5 Foreign currency translation

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured at historical cost in a foreign currency are not retranslated.

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into HK\$. Assets and liabilities have been translated into HK\$ at the closing rates at the reporting date. Income and expenses have been converted into HK\$ at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been dealt with in the translation reserve in equity. Goodwill and fair value adjustments arising on the acquisition of a foreign operation have been treated as assets and liabilities of the foreign operation and translated into HK\$ at the closing rate.

When a foreign operation is sold, such exchange differences are reclassified from equity to profit or loss as part of the gain or loss on sale.

2.6 Property, plant and equipment

Property, plant and equipment are stated at acquisition cost less accumulated depreciation and any impairment losses. Exploration and production properties include the expenditures for wells and related facilities in the course of exploration and production activities. Exploration and evaluation expenditures are accounted for using the "successful efforts" method of accounting. Costs are accumulated on a field-by-field basis. Geological and geophysical costs are expensed as incurred. Costs directly associated with an exploration well, and exploration and property leasehold acquisition costs, are capitalised until the determination of reserves is evaluated. If it is determined that commercial discovery has not been achieved, these costs are charged to expense.

Depreciation is provided to write off the cost over their estimated useful lives, using the straight-line method, at the following rates per annum:

The assets' estimated useful lives and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

The gain or loss arising on retirement or disposal is determined as the difference between the net sale proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to profit or loss in the year in which they are incurred.

2.7 Leasehold land and land use rights

Upfront payments made to acquire land held under an operating lease were stated at cost less accumulated amortisation and any impairment losses. Amortisation was calculated on straight-line method over the term of the lease/ right of use except where an alternative basis is more representative of the time pattern of benefits to be derived by the Group from use of the land.

As part of improvements to HKFRSs issued in 2009, HKAS 17 has been amended in relation to the classification of leasehold land. The Group concluded that the classification of such leases as operating leases is not appropriate and the leasehold interests will no longer be classified by the Group as operating leases as the Group considers that it is in a position economically similar to that of a purchaser. Accordingly, the Group has retrospectively reclassified the interests from "Leasehold land and land use rights" to "Property, plant and equipment". These amendments had no impact on the Group's retained profits and current year results.

2.8 Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest to earn rental income and/or for capital appreciation.

When the Group holds a property interest under an operating lease to earn rental income and/or for capital appreciation, the interest is accounted for as an investment property on a property-by-property basis. Any such property interest which has been classified as an investment property is accounted for as if it were held under a finance lease.

On initial recognition, investment property is measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is stated at fair value. Fair value is determined by external professional valuers, with sufficient experience with respect to both the location and the nature of the investment property. The carrying amounts recognised in the statement of financial position reflect the prevailing market conditions at the reporting date.

Gains or losses arising from either changes in the fair value or the sale of an investment property are included in profit or loss for the period in which they arise.

For property occupied by the Group as an owner-occupied property which becomes an investment property, the Group accounts for such property in accordance with the policy of property up to the date of change in use, and any difference at that date between the carrying amount and fair value of the property is dealt with in asset revaluation reserve. On disposal of the property, the asset revaluation reserve is transferred to retained profits as a movement in reserves.

As described in note 1 to the consolidated financial statements, the Group's only investment property was disposed of during the year. The investment property constituted a core part of the Group's property investment business. In accordance with HKFRS 5, the Group reclassified the investment property, at the end of the previous reporting period as held for sale in the Group's consolidated statement of financial position.

2.9 Goodwill

Goodwill is initially recognised at cost being the excess of the aggregate of consideration transferred and the amount recognised for non-controlling interests over the fair value of identifiable assets, liabilities and contingent liabilities acquired.

Where the fair value of identifiable assets, liabilities, and contingent liabilities exceed the fair value of consideration paid, the excess is recognised in profit or loss on the acquisition date, after re-assessment.

Goodwill is measured at cost less impairment losses. For the purpose of impairment testing, goodwill arising from an acquisition is allocated to each of the relevant cash-generating units that are expected to benefit from the synergies of the acquisition. A cash-generating unit to which goodwill has been allocated is tested for impairment annually, and whenever there is an indication that the unit may be impaired.

For goodwill arising on an acquisition in a financial year, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that financial year. When the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is allocated to reduce the carrying amount of any goodwill allocated to the unit first, and then to the other assets of the unit pro-rata on the basis of the carrying amount to each asset in the unit. Any impairment loss for goodwill is recognised in profit or loss and is not reversed in subsequent periods.

Intangible assets (other than goodwill)

Acquired intangible assets are recognised initially at cost. After initial recognition, intangible assets with indefinite useful lives are carried at cost less any impairment losses. Amortisation for intangible assets with finite useful lives is provided on a straight-line basis over their estimated useful lives. Amortisation commences when the intangible assets are available for use. Intangible assets are tested for impairment as described below in note 2.19.

Intangible assets include exploration and production services rights in respect of the cooperation right of crude oil extraction which are recognised at fair value upon business combination and are amortised on straight-line method over the period of the related service contract.

Intangible assets also include computer software, licence, customer relationship and retailer contracts which are recognised upon business combination and are amortised on straight-line method over 5 years.

Accounting policies for impairment of intangible assets have been set out in note 2.19 below.

Financial assets are classified into financial assets at fair value through profit or loss, loans and receivables and available-for-sale financial assets. Management determines the classification of its financial assets at initial recognition depending on the purpose for which the financial assets were acquired and where allowed and appropriate, re-evaluates this designation at every reporting date.

All financial assets are recognised when, and only when, the Group becomes a party to the contractual provisions of the instrument. Regular way purchases of financial assets are recognised on trade date, that is, the date that the Group commits to purchase or sell the asset. When financial assets are recognised initially, they are measured at fair value, plus, in the case of investments not at fair value through profit or loss, directly attributable transaction costs.

Derecognition of financial assets occurs when the rights to receive cash flows from the investments expire or are transferred and substantially all of the risks and rewards of ownership have been transferred. At each reporting date, financial assets are reviewed to assess whether there is objective evidence of impairment. If any such evidence exists, impairment loss is determined and recognised based on the classification of the financial asset.

(i) *Financial assets at fair value through profit or loss*

Financial assets at fair value through profit or loss are mainly financial assets held for trading and they are acquired for the purpose of selling in the near term, or it is part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent pattern of short-term profit-taking. Derivatives, including separated embedded derivatives are also classified as held-for-trading unless they are designated as effective hedging instruments or financial guarantee contracts.

Financial assets may be designated at initial recognition as at fair value through profit or loss if the following criteria are met:

- the designation eliminates or significantly reduces the inconsistent treatment that would otherwise arise from measuring the assets or recognising gains or losses on them on a different basis; or
- the assets are part of a group of financial assets which are managed and their performance is evaluated on a fair value basis, in accordance with a documented risk management strategy and information about the group of financial assets is provided internally on that basis to the key management personnel; or
- the financial asset contains an embedded derivative that would need to be separately recorded.

Subsequent to initial recognition, the financial assets included in this category are measured at fair value with changes in fair value recognised in profit or loss. Fair value is determined by reference to active market transactions or using a valuation technique where no active market exists. Fair value gain or loss does not include any dividend or interest earned on these financial assets. Dividend and interest income is recognised in accordance with the Group's accounting policies in note 2.18 to these financial statements.

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. These are subsequently measured at amortised cost using the effective interest method, less any impairment losses. Amortised cost is calculated taking into account any discount or premium on acquisition and includes fees that are an integral part of the effective interest rate and transaction cost.

(iii) *Available-for-sale financial assets*

These include non-derivative financial assets that do not qualify for inclusion in any of the other categories of financial assets.

All financial assets within this category are subsequently measured at fair value. Gain or loss arising from a change in the fair value excluding any dividend and interest income is recognised in other comprehensive income and accumulated separately in the available-for-sale financial assets revaluation reserve in equity, except for impairment losses (see the policy below) and foreign exchange gains and losses on monetary assets, until the financial asset is derecognised, at which time the cumulative gain or loss previously recognised in equity would be reclassified to profit or loss. Interest calculated using the effective interest method is recognised in profit or loss.

The fair value of available-for-sale monetary assets denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the reporting date. The change in fair value attributable to translation differences that result from a change in amortised cost of the asset is recognised in profit or loss, and other changes are recognised in other comprehensive income.

For available-for-sale investments in equity securities that do not have a quoted market price in an active market and whose fair value cannot be reliably measured and derivatives that are linked to and must be settled by delivery of such unquoted equity instruments, they are measured at cost less any identified impairment losses at each reporting date subsequent to initial recognition.

- significant financial difficulty of the debtor;
- a breach of contract, such as a default or delinquency in interest or principal payments;
- it becoming probable that the debtor will enter bankruptcy or other financial reorganisation;
- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; or
- a significant or prolonged decline in the fair value of an investment in an equity instrument below its cost.

Loss events in respect of a group of financial assets include observable data indicating that there is a measurable decrease in the estimated future cash flows from the group of financial assets. Such observable data includes but not limited to adverse changes in the payment status of debtors in the group and, national or local economic conditions that correlate with defaults on the assets in the group.

The amount of impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). The amount of the loss is recognised in profit or loss of the year in which the impairment occurs.

If, in subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed to the extent that it does not result in a carrying amount of the financial asset exceeding what the amortised cost would have been had the impairment not been recognised at the date the impairment is reversed. The amount of the reversal is recognised in profit or loss of the year in which the reversal occurs.

(ii) Available-for-sale financial assets

When a decline in the fair value of an available-for-sale financial asset has been recognised directly in equity and there is objective evidence that the asset is impaired, an amount is removed from equity and recognised in profit or loss as an impairment loss. That amount is measured as the difference between the asset's acquisition cost (net of any principal repayment and amortisation) and current fair value, less any impairment loss on that asset previously recognised in profit or loss.

When the Group is satisfied that recovery of loans and receivables is remote, the amount considered irrecoverable is written off against loans and receivables directly and any amounts held in the allowance account in respect of that receivable are reversed. Subsequent recoveries of amounts previously charged to the allowance account are reversed against the allowance account. Other changes in the allowance account and subsequent recoveries of amounts previously written off directly are recognised in profit or loss.

Impairment losses recognised in interim period in respect of unquoted equity securities carried at cost are not reversed in a subsequent period. Consequently, if the fair value of an available-for-sale equity security increases in the remainder of an annual period, or in a subsequent period, the increase is recognised in other comprehensive income.

Inventories are carried at the lower of cost and net realisable value. Cost is determined using weighted average method. Net realisable value is the estimated selling price in the ordinary course of business less the estimated cost of completion and any applicable selling expenses.

When the inventories are sold, the carrying amount of those inventories is recognised as an expense in the year in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the year in which the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the year in which the reversal occurs.

2.13 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short-term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value which are repayable on demand and form an integral part of the Group's cash management.

2.14 Financial liabilities

The Group's financial liabilities include trade payables, other payables and accrued charges, amounts due to associates, amounts due to fellow subsidiaries of an associate and obligations under finance leases.

Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. All interest related charges are recognised in accordance with the Group's accounting policy for borrowing costs (see note 2.21).

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expired.

Obligations under finance leases

These are measured at initial value less the capital element of lease repayments (see note 2.15).

Trade payables, other payables and accrued charges, amounts due to associates and amounts due to fellow subsidiaries of an associate

These are recognised initially at fair value and subsequently measured at amortised cost less settlement payments, using effective interest method.

2.15 Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

(i) Classification of assets leased to the Group

Assets that are held by the Group under leases which transfer to the Group substantially all the risks and rewards of ownership are classified as being held under finance leases. Leases which do not transfer substantially all the risks and rewards of ownership to the Group are classified as operating leases.

Subsequent accounting for assets held under finance lease agreements corresponds to those applied to comparable acquired assets. The corresponding finance lease liability is reduced by lease payments less finance charges.

Finance charges implicit in the lease payments are charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period. Contingent rentals are charged to profit or loss in the accounting period in which they are incurred.

(iii) *Operating lease charges as the lessee*

Where the Group has the right to use of assets held under operating leases, payments made under the leases are charged to profit or loss using straight-line method over the lease terms except where an alternative basis is more representative of the time pattern of benefits to be derived from the leased assets. Lease incentives received are recognised in profit or loss as an integral part of the aggregate net lease payments made. Contingent rental are charged to profit or loss in the year in which they are incurred.

Rental income receivable from operating leases is recognised in profit or loss on straight-line method over the periods covered by the lease term, except where an alternative basis is more representative of the time pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the year in which they are earned.

2.16 Provisions, contingent liabilities and contingent assets

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Ordinary shares are classified as equity. Share Capital is determined using the nominal value of shares that have been issued.

Any transaction costs associated with the issuing of shares are deducted from share premium (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

The consideration payable on repurchase or cancellation of the Company's ordinary share is deducted from equity. No gain or loss is recognised in profit or loss on the repurchase or cancellation of the Company's ordinary shares.

2.18 Revenue recognition

Revenue comprises the fair value for the sale of goods and services and the use by others of the Group's assets yielding interest and dividends, net of applicable value-added tax ("VAT"), rebate and discounts. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised as follows:

Sales of goods are recognised upon transfer of the significant risks and rewards of ownership to the customer. This is usually taken as the time when the goods are delivered and the customer has accepted the goods.

Exploration and production services income and management fee income are recognised when the related services are rendered.

Interest income is recognised on time-proportion basis using effective interest method.

2.19 Impairment of non-financial assets

Goodwill, property, plant and equipment, interests in subsidiaries and associates and intangible assets are subject to impairment testing.

Goodwill and intangible assets with an indefinite useful life or those not yet available for use are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of fair value, reflecting market conditions less costs to sell, and value-in-use. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a CGU). As a result, some assets are tested individually for impairment and some are tested at CGU level.

Any remaining impairment loss is charged pro rata to the other assets in the CGU, except that the carrying amount of an asset will not be reduced below its individual fair value less cost to sell, or value-in-use, if determinable.

An impairment loss on goodwill is not reversed in subsequent periods including impairment losses recognised in an interim period. In respect of other assets, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

Under the Listing Rules, the Group is required to prepare an interim financial report in compliance with HKAS 34 – Interim Financial Reporting, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition and reversal criteria as it would at the end of the financial year.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

Retirement benefits

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution Mandatory Provident Fund retirement benefit plan (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme.

The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group's employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

The employees of the Group's subsidiaries which operate in the PRC are required to participate in a central pension scheme operated by the local municipal government. The subsidiaries are required to contribute certain percentage of its payroll costs to the central pension scheme.

Contributions are recognised as expenses in profit or loss as employees rendered services during the year. The Group's obligations under these plans are limited to the fixed percentage contribution payable.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

Share-based employee compensation

All share-based payment arrangements granted after 7 November 2002 and had not vested on 1 January 2005 are recognised in the financial statements. The Group operates equity-settled share-based compensation plans for remuneration of its employees, directors and in exchange for goods and services.

All employee services received in exchange for the grant of any share-based compensation are measured at their fair values. These are indirectly determined by reference to the equity instruments awarded. Their value is appraised at the grant date and excludes the impact of any non-market vesting conditions (for example, profitability and sales growth targets).

All share-based compensation is recognised as an expense in profit or loss over the vesting period if vesting conditions apply, or recognised as an expense in full at the grant date when the equity instruments granted vest immediately unless the compensation qualifies for recognition as asset, with a corresponding increase in the share option reserve in equity. If vesting conditions apply, the expense is recognised over the vesting period, based on the best available estimate of the number of equity instruments expected to vest. Non-market vesting conditions are included in assumptions about the number of equity instruments that are expected to become exercisable. Estimates are subsequently revised, if there is any indication that the number of equity instruments expected to vest differs from previous estimates. No adjustment to expense recognised in prior periods is made if fewer share options ultimately exercised than originally vested.

Share options granted to suppliers/consultants

Share options issued in exchange for goods or services are measured at the fair values of the goods or services received. The fair value is measured at the date the Group obtains the goods or the counterparty renders service.

2.21 Borrowing costs

Borrowing costs incurred for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time get ready for its intended use or sale. Other borrowing costs are expenses when incurred.

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, tax authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at the tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

The business components in the internal financial information reported to the executive directors are determined following the Group's major product and service lines.

The Group has identified the following reportable segments:

- Publishing: Publication of comic books and royalty income from licensing comic books
- Crude oil exploration services: Crude oil exploration services in the People's Republic of China (the "PRC")
- Chinese information infrastructure and online social music gaming platform: Provision of server management, data warehousing services and development of online social music gaming platform
- Electronic card service: Electronic card payment services in convenience stores, supermarkets, fast-food restaurants, hotel, online shopping and other point-of-sale applications such as service stations and vending machines
- Retailing and wholesales: Retailing of clothes, cosmetics and ladies accessories and red wine in Hong Kong and Macau and wholesales of insulation materials in Japan
- Property investments (which were discontinued during the year)

Information about other business activities and operating segments that are not reportable are combined and disclosed in "Others". Others included catering services in Macau.

Each of these operating segments is managed separately as each of the product and service lines requires different resources as well as marketing approaches. All inter-segment transfers are carried out at arm's length prices.

In addition, corporate assets which are not directly attributable to the business activities of any operating segment are not allocated to a segment, which primarily applies to the Group's headquarter.

Segment liabilities exclude amounts due to fellow subsidiaries of an associate, amounts due to associates and liabilities of discontinued operations as well as corporate liabilities, which are not directly attributable to the business activities of any operating segment and are not allocated to a segment. These include income tax payables.

Impairment of property, plant and equipment and intangible assets

The Group assesses impairment at each reporting date by evaluating conditions specific to the Group that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number of key estimates and assumptions about future events, which are subject to uncertainty and might materially differ from the actual results. In making these key estimates and judgements, the directors take into consideration assumptions that are mainly based on market condition existing at the reporting dates and appropriate market and discount rates. These estimates are regularly compared to actual market data and actual transactions entered into by the Group.

Assessment of impairment of goodwill

The Group tests annually whether goodwill has suffered impairment in accordance with the accounting policy stated in note 2.9. The recoverable amounts of CGUs have been determined based on value-in-use calculations. These calculations require the use of estimates about future cash flows and discount rates. In the process of estimating expected future cash flows, management makes assumptions about future revenues and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of goodwill within the next financial year. Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors. Details of the estimates of the recoverable amounts of CGUs containing goodwill are disclosed in note 19.

Estimation of exploration and production service rights

Estimates of crude oil reserves are the important element in determining the fair value of the exploration and production service rights and testing for impairment. Proved plus probable reserves and unrisks prospective resources estimates are subject to revision, either upward or downward, based on new information, such as from development drilling and production activities or from changes in economic factors, including product prices, contract terms and development plans. In general, changes in the technical maturity of oil reserves resulting from new information becoming available from development and production activities have tended to be the most significant cause of annual revisions.

Impairment of receivables

The Group estimates impairment losses for bad and doubtful debts resulting from the inability of the customers to make the required payments. The estimates are made with reference to the ageing of the accounts receivable balance, customer credit-worthiness, and historical write-off experience. If the financial condition of the customers were to deteriorate, actual write-offs would be higher than the estimate.

Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market conditions and the historical experience of selling products of a similar nature. It could change significantly as a result of competitor actions in response to severe industry cycles. Management reassesses these estimations at the reporting date to ensure inventory is stated at the lower of cost and net realisable value.

The realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future profits generated are less than expected, a reversal of the deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal takes place.

Carrying value of available-for-sale financial assets and financial assets at fair value through profit or loss

Unlisted equity share investments

The Group's available-for-sale financial asset and financial assets at fair value through profit or loss include certain unlisted equity share investments that do not have a quoted market price in an active market and whose fair value, in the opinion of the directors, cannot be reliably measured. Accordingly, the Group has reflected these financial assets at cost less any impairment losses.

Changing the assumptions selected by management to determine the level of impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect net present value used in the impairment test.

The amortisation period of the Cooperation right was 20 years, in accordance with the terms of the Da Ming agreement. At 31 March 2012, the remaining amortisation period of the Cooperation right was 14.25 years.

The computer software, licence, customer relationship and retailer contracts are intangible assets acquired on 31 May 2009 through the acquisition of 上海旅聯. The fair values of these intangible assets were carried out by Ascent Partners, an independent qualified professional valuer, not connected with the Group and with appropriate qualification and experience in the valuation of similar assets in the relevant industry. However, total maximum number of shares of the Company which might be issued upon exercise of all outstanding share options granted and yet to be exercised under the New Option Scheme and any other share option scheme must not exceed 30% of the shares of the Company in issue from time to time.
- (iv) The maximum number of shares of the Company in respect of which share options might be granted to a participant, when aggregated with shares issued and issuable (including exercised and outstanding share options and the options cancelled) under any share option granted to the same participant under the New Option Scheme or any other share option scheme within any 12 month period, must not exceed 1% of the shares of the Company in issue from time to time.

The Group is exposed to financial risk through its use of financial instruments in its ordinary course of operations and in its investment activities. The financial risks include market risk (including currency risk, interest risk and other price risk), credit risk and liquidity risk.

Financial risk management is coordinated at the Group's headquarters, in close co-operation with the board of directors. The overall objectives in managing financial risks focus on securing the Group's short to medium term cash flows by minimising its exposure to financial markets. Long term financial investments are managed to generate lasting returns with acceptable risk levels.

It is not the Group's policy to actively engage in the trading of financial instruments for speculative purposes. The operation management works under the policies approved by the board of directors. It identifies ways to access financial markets and monitors the Group's financial risk exposures. Regular meeting are held with the board of directors.

Foreign currency risk

The Group's functional currency is Hong Kong dollars. The Group is exposed to currency risk primarily through certain revenues and expenses giving rise to investments, receivables, payables and cash balances that are denominated in other currencies, being primarily United States dollars (USD), Australian dollars (AUD), European dollar (EUR), Macau Pataca (MOP) and Renminbi (RMB). As USD and Macau Pataca are pegged to Hong Kong dollar (HKD), the Group does not expect any significant movements in the USD/HKD and MOP/HKD exchange rates. The Group is mainly exposed to foreign exchange risk arising from future transactions that are denominated in AUD, EUR and RMB. The management monitors foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise.

(i) *Exposure to currency risk*

Interest rate risk

The Group is exposed to interest rate risk through the impact of rate changes on interest bearing assets. The Company's policy is to obtain the most favorable interest rates available for its deposits.

As at 31 March 2012, the (loss)/profit after tax of the Group would have been decreased/increased by approximately HK\$435,000 (2011: HK\$258,000) if the market interest rate had been increased/decreased by 100 basis points with all other variables held constant. The 100 basis points increase/decrease represents management's assessment of the likely maximum change in interest rates over the period until the end of the next reporting period. The analysis is performed on the same basis for 2011.

Equity price risk

The Group is exposed to equity price risk through its investment in listed equity securities which are classified as financial assets at fair value through profit or loss. The directors manage this exposure by maintaining a portfolio of investments with different risk and return profiles and will consider hedging the risk exposure should the need arise.

At 31 March 2012, it is estimated that there is a reasonably possible change of 15% (2011: 15%) in stock price in the next twelve months. If equity price had increased/(decreased) by 15% (2011: 15%) and all other variables were held constant, profit for the year would increase/(decrease) by HK\$7,637,000 (2011: HK\$9,310,000). This is mainly due to the change in financial assets at fair value through profit or loss. This sensitivity analysis has been determined assuming that the price change had occurred at the reporting date and had been applied to the Group's investment on that date.

The Group's exposure to credit risk is influenced mainly by the individual characteristic of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, 95% (2011: 87%) of the total trade receivables was due from the Group's top three customers within the publishing and crude oil exploration services.

The credit risk for financial assets at fair value through profit or loss and liquid funds is considered negligible as the counterparties are reputable banks in either Hong Kong or the PRC.

The Group adopts conservative investment strategies. For investments in financial assets at fair value through profit or loss, only issuers with good credit ratings would be considered.

The credit and investment policies have been followed by the Group since prior years and are considered to have been effective in limiting the Group's exposure to credit risk to a desirable level.

(c) Liquidity risk

As at 31 March 2012, the Group had net current assets of HK\$557,621,000 and bank balances and deposits with financial institutions of HK\$434,531,000. Management considered the liquidity risk is minimal.

Management regularly monitors current and expected liquidity requirements to ensure it maintains sufficient reserves of cash and bank balances and adequate funding from its shareholders to meet with its liquidity requirements.

- (a) To safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for its stakeholders; and
- (b) To maintain an optimal capital structure to reduce the cost of capital and to support the Group's stability and growth.

The Group actively and regularly reviews and manages its capital structure to ensure optimal capital structure and shareholder returns, taking into consideration the future capital requirements of the Group and capital efficiency, prevailing and projected profitability, projected operating cash flows, projected capital expenditures and projected strategic investment opportunities. The Group currently does not adopt any formal dividend policy. Management may adjust the share option policy and issuance of warrants and ordinary shares policy.

Management regards total equity of HK\$758,936,000 (2011: HK\$779,150,000) as capital, for capital management purpose.

44. EVENTS AFTER REPORTING DATE

On 20 June 2012, the Group received a letter from a connected party, namely, Wealth Concept Holdings Limited, requesting an extension of the repayment date for the remaining balance of HK\$2,654,000 to 31 July 2012. The Group accepted the request and will take any appropriate actions necessary to recover the outstanding indebtedness if Wealth Concept Holdings Limited fails to honor their promise and commitment by 31 July 2012.
