Remarks (if any):

As disclosed in the Company's announcement dated 17 December 2010 (the "**Announcement**"), the purposed Capital Reorganisation involved the Capital Reduction (the "**Capital Reduction**") and Increase in Authorised Share Capital have been approved by the shareholders at the special general meeting (the "**SGM**") held on 24 January 2011.

1. Capital Reduction

- (i) The reduction of the issued share capital of the Company through a cancellation of the paid-up capital of the Company to the extent of HK\$0.99 on each of the issued shares so that the nominal value of each issued ordinary share will be reduced from HK\$1.00 to HK\$0.01;
- (ii) The reduction of the authorised share capital of the Company by reducing the nominal value of all shares from HK\$1.00 to HK\$0.01

2. Increase in Authorised Share Capital

Upon the effective of the Capital Reduction, the authorised share capital of the Company is \$10,000,000 divided into 1,000,000,000 shares. Pursuant to the approval granted from the shareholders in the SGM, the authorised share capital of the Company increased from HK\$10,000,000 divided into 1,000,000,000 shares of HK\$0.01 each to HK\$2,000,000,000 divided into 200,000,000,000 shares at HK\$0.01 each.
